



The Village Chicago Reduced Fee Fact Sheet

The Village Chicago is committed to all our neighbors, regardless of income, to join and participate fully in Village life. There are three reduced fee levels available to those who meet the eligibility requirement. Automatic monthly and quarterly payment plans are available as well.

Individuals	Households
Level 1: \$8.33 monthly or \$100 annually	Level 1: \$12.50 monthly or \$150 annually
*Income: \$32,000 or less	*Income: \$43,000 or less

Individuals	Households
Level 2: \$16.67 monthly or \$200 annually	Level 2: \$25 monthly or \$300 annually
*Income: \$32,001 - \$45,000	*Income: \$43,001 - \$60,000

Individuals	Households
Level 3: \$25 monthly or \$300 annually	Level 3: \$33.33 monthly or \$400 annually
*Income: \$45,001 - \$57,000	*Income: \$60,001 - \$77,000

*Income is based on total adjusted gross income (including social security benefits and other nontaxable income.)

To confirm eligibility, individuals must show the first two pages of their most recent federal tax return or other proof that income meets the criteria outlined here. Eligibility is based on total adjusted gross income. All information remains confidential.
